



Hooters Casino Hotel \$1,000,000 Press For Cash Dare Devil “You Spin & You Win”

Official Rules

- Must be a Rewards Club+ member, 21 years of age or older to participate and be able to present a valid state-issued photo ID (driver's license, state identification card, or military identification card) in order to collect prize. If winner is not a U.S. citizen, a current passport or alien registration card is required.
