Official Rules**

Must be a Hooters Rewards Club member, 21 years of age or older to participate and must be able to present a valid state-issued photo ID (driver's license, state identification card, or military identification card) in order to collect prize. If winner is not a U.S. citizen, a current passport or alien registration card is required.
